Scope and Contents of the Collection:

This collection consists of the papers belonging to the City Attorney between 1915 and 1963. The City Attorney Papers contain correspondence, notes, legal materials, and ephemera related to the work of several City Attorneys who served Nashville, largely including W.C. Cherry, Charles G. Blackard, Claude Callicott, and E.C. Yokley. The majority of the collection covers 1938-1963, and reflects the legal workings of Nashville under Mayor Thomas L. Cummings and Mayor Ben West. Correspondence with businesses and various departments and agencies within the City of Nashville make up a large portion of this collection. Also included are legal opinions, personal injury and property claims, correspondence and plans regarding city projects, case files from law suits, and city, state, and federal legislation.
