## Historical/Biographical Note:

The official history of the Circuit Court for Davidson County dates back to when the court was duly organized on March 12, 1810, with Thomas Stuart as its first judge. However, we have records that date back to 1802, which indicate that some cases were heard in a circuit court within Davidson County before this official beginning of the First Circuit Court. This early history of the court is fragmentary, but the case files that survive give a glimpse into what types of cases and with what frequency they might have been heard. This court deals with civil cases, including small claims, divorce, alimony, personal injury, and contract disputes. The case load of the First Circuit Court increased greatly, to the point that it was necessary for the legislature to establish the Second Circuit Court on February 6, 1895, with Claude Waller as its first judge. By 1913, once again with the growth of population in the county, the legislature appointed George N. Tillman as the first judge of the Third Circuit Court.

### Scope and Contents of the Collection:

The Circuit Court Case files contain approximately 742 individual cases heard in the First, Second, or Third Circuit Courts of Davidson County. Case files include official court documents, memoranda, correspondence, or invoices used in court proceedings for respective cases. Court and legal documents include depositions, divorce records, petitions, financial claims, and property claims. Records span from 1802 to 1959.
