Historical Note:

While the history of the Davidson County Court is patchy at best, its beginnings can be traced back to 1783, with Andrew Ewing as the first County Court Clerk and James Robertson elected as the first County Judge. The responsibilities and activities of Davidson County Court extended beyond lawsuits to include the settlement of estates, the building of roads and ferries, mental competency cases, name changes, naturalizations, indentures, adoptions, and guardianship. The Davidson County Court was later consolidated into the General Sessions Court following the approval of a lower court reform bill in 1971.

Scope and Contents of the Collection:

This large collection consists of numerous documents and reports relating to the activities and workings of the Davidson County Court, including official court and legal documents, notes and correspondence, meeting minutes, and reports from the Davidson County Court. Court and legal documents include resolutions, acts, committal papers, adoptions, estate papers, guardian papers, depositions and case files, and petitions. Notes and correspondence pertain to resignations, appointments, and requests for appropriation from various county boards and commissions. Records span from 1797 to 1978. This collection documents the long history of the Davidson County Court and gives a glimpse into how the County Court operated, as well as the changes it made to Nashville and Davidson County.

Arrangement:

This collection is arranged into twelve series, including *adoption papers*, *charitable and per capita institutions*, *charters of incorporation*, *committees*, *county officials*, *court papers*, *courts, departments and commissions*, *estate papers*, *general government*, *guardian papers*, and *licenses*.

The *adoption papers* series consists of petitions, decrees, and other court papers pertaining to adoptions taking place between 1881 and 1937. Series is arranged alphabetically by name; however, access is restricted.

The *charitable and per capita institutions* series contains reports, petitions, resolutions, and applications for several charitable institutions in Nashville and Davidson County. Institutions include Crippled Children's Service Work, Fannie Battle Day Home, Monroe-Harding Children's Home, and the Nashville Relief Society.

Charters of incorporation include charters for the City View Sanitarium, Hermitage Club of Nashville, International Freight Bureau, Metropolis Pottery and Fire Brick Co., Hydrated Lime Co., Planters Fertilizer Co., The Tennessee Company, and United Knights and Daughters of Love.

The *committees* series contains court papers, notes, meeting minutes, and reports relating to various committees in Davidson County. Notable items include reports and resolutions of the Agricultural Committee, reports of the Public School Committee, and records documenting the activities of the Voting Machine Committee.

The *county officials* series consists of reports, applications, correspondence, and court papers from various county officials, including the Attorney General, the Coroner, Fisk Commissioner, and the Turnpike Superintendent.

Court papers include committal records, court cases, garnishments, indentures, power of attorney, property issues, and trustee records. Some cases contain only one item, while others may contain several documents. It should be noted that the committal records are documents of the actions of the County Court rather than health records; however, access to all committal records from 1950-1965 is restricted.

The *courts* series contains forms, reports, meeting minutes, bonds, and resolutions relating to several courts in Davidson County, including Chancery, Circuit, County, Criminal, General Sessions, Juvenile, and Quarterly Court.

The *departments and commissions* series contains reports, resolutions, and court papers belonging to various departments and commissions in Davidson County. Notable items include reports and resolutions from the Board of Education, papers documenting the activities of the Davidson County Board of Health, and reports of the Tennessee State Fair from 1948-1956.

Estate papers include documents relating to the settling of individual estates. Series is arranged alphabetically by name, and dates range largely from 1855-1960.

The *general government* series contains correspondence, reports, and other information involving general court/government procedures. Items include beverage bonds, election information, petitions, poll tax, private acts, public building and courthouse resolutions from 1937-1958, and information regarding voting precincts.

Guardian papers include official documents relating to guardianship of minor children and/or disabled adults. Series is arranged alphabetically by name of child or adult being appointed a guardian. Name of guardian is included in the description.

The *licenses* series includes licenses for business, insurance, law, nursing, ordinary, and peddlers.
